## NOTICE TO BIDDERS

The City of Celina will receive sealed bids for the West Logan Street Improvement Project/Meyer Road Storm Extension.

Bids will be received in the office of the Safety-Service Director, 426 West Market Street, Celina, Ohio 45822 until 11:00 a.m. April 3, 2009 at which time and place bids will be opened publicly and read aloud. Bids received after 11:00 a.m. (local time) will be returned unopened.

A Unit Price bid will be considered for:

Total Construction Costs:	Base Bid A - Roadway Improvements – West Logan Street
	Base Bid B – Meyer Road Storm Sewer
	Combined Bid – Base Bid A + Base Bid B

Bids must be signed and submitted on the separate bidding forms included in the Bidding Documents, sealed in the provided envelope. Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code in the amount of 100% of the Bid amount, or by a certified check, cashier's check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. The successful BIDDER will be required to furnish a satisfactory Performance and Payment Bond in the amount of 100% of the Bid.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio Products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates for Public Improvements in Mercer County and the City of Celina as determined by the Ohio Bureau of Employment Services, Wage and Hour Division, (614) 644-2239.

The Bidding Documents, which include drawings and specifications may be examined and obtained at the office of Fanning/Howey Civil Engineering Division, 1200 Irmscher Blvd., Celina, OH 45822. Bidders may obtain copies of the documents from the Engineer for \$75.00 for each complete set of documents. Non-refundable checks are to be payable to Fanning/Howey Associates, Inc.

The Owner reserves the right to reject each and every bid and to waive informalities, irregularities, and errors in the bidding to the extent permitted by law.

No bidder may withdraw their bid within 90 days after the actual date of the opening thereof.
