## Snow Removal



Once again the Winter season is approaching. With it comes snow and ice. You can assist with snow removal in several ways:

- \* Residents are not to blow or shovel snow into city streets or allow private contractors hired to plow their driveways to do so.
- \* All vehicles must be moved from the street when an accumulation of snow is expected to allow plowing while preventing vehicles from being buried or damaged.
- \* For safety, stay as far away from snow plows as possible.
- \* Keep children away from snow plows.
- \* Keep parked cars off the street during snow events.
- \* Do not attempt to pass a snow plow.
- \* Do not attempt to drive through deep snow.
- \* Keep sidewalks clear of snow and ice.

To provide a more thorough and quicker snow removal service, residents are reminded not to park their vehicles on the street after a snowfall.

By Ordinance, residents and businesses are required to keep their sidewalks in repair and free of ice, snow, debris, and obstructions.

Reminder for extreme frigid temperatures, Celina Utilities urges all customers to take precaution and protect their water lines. Leaving cabinet doors open in colder areas of your building and or allowing a small amount of water to drip could prevent expensive repairs from freezing pipes.



Also, please be aware that during cold temperatures, we will not open water meter pits to get a reading. You will receive an estimated bill based on the previous month usage.

Prompt payment of your utility bills to avoid getting your services shut off is important. Any customer with a past-due account balance is subject to disconnect. Customers can determine their account status by checking their monthly utility bill. If your bill indicates you are in disconnect status, prompt payment is necessary to avoid having your utilities turned off. Payments can be made to the Celina Utilities office with cash, check, automatic deduction from your bank account, or credit card. A night deposit box is located outside of the front doors for payment after working hours.

**Any customer who has had their utilities turned off due to nonpayment, must make payment with cash or money order to be reconnected.**
